Background

The Officials Advisory Panel was established in 2017 and is charged with.

- A) Ensuring a contemporary and targeted approach to officials training and education.
- B) Revision of current roles and responsibilities and refine as appropriate to improve officiating experiences and encourage participation.
- C) Recommend revisions of the Surf Sports Manual to ensure competition is structured to promote participation and fair competition.
- D) Lead the appointment process for SLSNSW Championships Referees and Deputy Referees.
- E) Collaborate with appointed Referees on their appointment of Officials.
- F) Consider the use of technology to enhance both official and competitor experiences.
- G) Develop strategies to ensure an on going pipeline of officials is developed.

Officials Advisory Panel Specifications

A maximum of three (3) applicants will join an existing panel consisting of a Chair, one (1) independent member, two (2) independent members up for re – nomination and two (2) SLSNSW staff.

All applicants must meet the following requirements:

- Be a current Financial Member of Surf Life Saving NSW
- A minimum of 5 years' service with Surf Life Saving NSW
- Have a robust understanding and extensive recent experience of Surf Sports Officiating across all disciplines.
- Have a general understanding of the NSW & Australian Surf Life Saving Championships.
- Be available to attend Surf Sports carnivals (within reason) throughout the 2023/24 season & 2024/25 season.

The tenure for all Officials Advisory Panel members will be two-year terms, for a maximum of three terms.

Additional Panel Members:

At the discretion of SLSNSW, the SLSNSW Chair of Surf Sports, additional members may be appointed to the panel or asked to attend meetings at any given time.

Attending Panel Meetings:

- On occasion, Members of the Panel will be required to meet face to face.
- The Panel meet every 4 weeks on a Tuesday evening via Zoom or as required for any urgent matters.
