## SECTION 1 GENERAL EVENT INFORMATION

### SHARKSKIN AUSTRALIAN IRB & INTERSTATE CHAMPIONSHIPS: 18-21 July 2024

The SHARKSKIN Australian IRB & Interstate Championships 2024 is a competition matching the best representative Inflatable Rescue Boat (IRB) teams from Australia's Surf Clubs, States and Territories.

This actioned packed event will showcase the expertise of each Club in the use of IRBs, Surf Life Saving Australia's frontline of rescue methods. Club teams will battle it out in the open ocean for the Harry Brown OAM Trophy for the Australian IRB Open Championship point score. The best crews from each State will also compete for the SLSA Interstate IRB Championship Trophy and contribute points to the Alan B Whelpton AO Perpetual Shield (for the overall Interstate point score of Ocean, Pool, Surf Boat and IRB Interstate Championships).

### INFORMATION SUMMARY

- The SHARKSKIN Australian & Interstate IRB Championships will be held at Miami Beach from 18-21 July 2024.
- Entries are now open through SEMS. Clubs who do not have a SEMS login are to request access first by completing the [IT Systems User Account Application Form](#).
- All entries close 5pm Friday, 5 July 2024.
- Scrutineering is to commence from 9am Wednesday 17 July 2024. Scrutineering timeslots will be made available to clubs once club entries have been submitted via SEMS. Team Managers must then email [events@slsa.asn.au](mailto:events@slsa.asn.au) to request a slot that will be confirmed and published upon the close of entries.
- Trailers/Containers can be dropped on site from 9:00am on Tuesday 16 July 2024. If any clubs are sending containers, you must contact [events@slsa.asn.au](mailto:events@slsa.asn.au) with all details listed.
- Team Managers must complete [IRB Championships Team Manager Form](#).
- The IRB Training Hour requirement is now a Member Award in SurfGuard. This will be required to be endorsed every season. Further details can be found in **Memo 3/23-24 - Introduction of IRB Training - Competition Eligibility Award in SurfGuard**

## SAFETY

All Clubs, States & Territories, Competitors and Officials are referred to the introduction of the 37<sup>th</sup> edition of the SLSA Surf Sports Manual. Paragraph (d) states:

*"Surf lifesaving can be inherently dangerous. Serious accidents can and often do happen which may result in property damage, physical injury and even death. All members are assumed to have voluntarily read and understood this warning and accept and assume the inherent risks in surf lifesaving."*

All Clubs, States & Territories, Competitors and Officials are also referred to the General Rules contained in the SLSA IRB Competition Rules Section 3.3 and in particular to the warning contained in SSM Section 3.3.2.1 that states:

**"WARNING:** *IRB competition can be inherently dangerous. IRB competition participants acknowledge that they are exposed to certain risks during IRB competition including but not limited to leg, spinal and neck injuries, physical exertion, contact with the IRB, temperature, weather and water conditions and even drowning. IRB competition participants acknowledge that accidents can and often do happen which may result in IRB competition participants being injured or even killed. All members through their participation in IRB events agree with, acknowledge and understand this warning and accept and assume the inherent risks in IRB competition."*

An Australian & Interstate IRB Championships 2024 Safety Operations Manual, including a Competition Contingency Plan has been developed for use by the IRBCCC, Officials and relevant personnel. The Championship Referee and SEMC will give a Safety Briefing to Officials and Team Managers before commencement of competition and during the event as required.

Water safety as part of the competition, is ultimately the responsibility of the IRBCCC. In accordance with Section 1 - Competition Safety, of the current edition of the SLSA Surf Sports Manual, any subsequent amending bulletins, and this circular, the IRBCCC is responsible to determine whether to postpone or cancel any or all events or relocate the Championships to an alternate venue based on the advice of the



SEMC, Championship Referee and Officials.

In response to ongoing reviews of carnival safety measures, additional Risk Assessors have been appointed to assist the SEMC to provide ongoing assessment of conditions and safety across the carnival area. They will create an effective communications channel to the SEMC and IRBCCC. Those Officials may seek advice from competitors and team representatives to ensure an informed opinion is provided and can be acted upon where appropriate.

A debrief with Officials will be conducted by the Championship Referee at the end of each day. Competitor/Team Manager Briefings will be called when required by the Championship Referee. These briefings will be conducted by the Championship Referee and/or Deputy Referee.

## SCRUTINEERING

Full technical scrutineering will be conducted for all clubs on **Wednesday 17<sup>th</sup> July ONLY**. All scrutineering to be done in accordance with IRB Equipment Requirements, Scrutineering and Compliance. Clubs are made aware that there will be ongoing random scrutineering and equipment reviews throughout the competition days and may be called again for full technical scrutineering at the end of each day of competition.

Note: It is the responsibility of each Club to ensure gear and equipment meets the manufacturers and/or SLSA specifications as set out in the current edition SLSA Bulletin Surf Sport IRB Competition - Gear and Equipment Regulations (or as amended).

Any Club found to be using equipment that does not meet manufacturers or SLSA Bulletin Surf Sport IRB Competition - Gear and Equipment Regulations, shall be referred to the Championship Referee for adjudication. Any equipment that does not meet these regulations will be excluded from the Championships and may face further disciplinary action.

If the failed equipment item / part is subsequently found to be used in Competition, the Club will be immediately disqualified from the Championships, where Coaches, Team Managers and athletes may face further disciplinary action. No competition points will accrue.

\*Patients do not need to be Masters or U23 aged competitors and can be of either gender in both Male and Female events.

**Note:** SLSA as the event organisers, reserves the right to add or delete any events on the day of competition if safety, weather conditions, programming or other conditions warrant.

### CLUB POINTSCORE

All events conducted shall be of equal points and the club with the highest aggregate of points at the conclusion of each Championships shall be declared the winner in each of the respective U23, Masters & Open Championships. The Club with the highest aggregate of points at the conclusion of each Championship shall be declared the winner.

Point score points shall be allocated on a 6, 5, 4, 3, 2, 1, basis for the positions 1<sup>st</sup> – 6<sup>th</sup> for each event contested. Nil points will be earned in the case of disqualification.

Where a dead heat occurs in the final of an event the Clubs involved will share the placing and placing points relative to the finish placing. The next Club to finish will receive the relative placing and placing points based on the number of individuals/teams finishing ahead of them. For example: if two individuals/teams finish equal 1<sup>st</sup> both individuals/teams shall receive 6 points each. The next placing individual/team shall be awarded 3<sup>rd</sup> place and 4 points.

If, when the Championships have concluded there is a tied point score, the Club with the most 1<sup>st</sup> placings will be declared the winner. Failing this, the Club with the most 2<sup>nd</sup> places to 6<sup>th</sup> places respectively will be considered to determine a winner. If, after this procedure there is no single winner, then the point score will be declared a tie and dual trophies will be presented.

**Note:** International clubs (and/or non SLSA affiliated clubs) are not eligible to earn points towards Australian Champion Club. Hence, any placing's achieved by non SLSA clubs will not be counted towards the overall point score and the points will be allocated in finals to the first 6 Australian Club place getters.



## ENTRIES

All entries must be completed online via SEMS and all relevant forms completed. It is the Club's responsibility to confirm that SLSA has received the entries prior to the event. Please note there is a separate 'Event' for the U23, Masters and Open Championships in SEMS.

## ELIGIBILITY TO COMPETE

To be eligible to compete at the IRB Championships, competitors must comply with Policy 5.04 – Competition Eligibility and the Guidelines for Competition Eligibility document (available on the SLSA Members Area).

Once an invoice has been generated following the close of entries, all entry fees are non-refundable.

Price is listed per competitor for entry across all eligible age divisions across U23, Open & Over 35's per Championship. For example, if a competitor is to enter both Masters & Opens competitions that individual will be charged \$70 entry fee for both Championships.

Clubs will not be able to compete unless all invoices are paid in full prior to the start of the Championships.

## PRIVACY

Personal details being collected by Surf Life Saving Australia are for the SHARKSKIN Australian & Interstate IRB Championships 2024. This personal information will not be disclosed to any other party. You have the right to access your personal information held by Surf Life Saving Australia.

## CONDITIONS OF ENTRY

### DECLARATION

It is an expressed condition of accepting entries that the Team Manager accepts the online form to indicate that all members listed on the Club's entries comply with all entry conditions and shall abide by the conditions of entry set out in this circular.

### PROFICIENCY AND PATROL REQUIREMENTS

All competitors entered in the SHARKSKIN Australian & Interstate IRB Championships 2024 must meet the requirements of SLSA policies. Further details may be obtained from Surf Life Saving Australia's Policy 5.4 – SLSA Guidelines for Competition Eligibility.

Notwithstanding the foregoing, Surf Life Saving Australia reserves the right to conduct a random or detailed audit of entries and under such circumstances, the selected Clubs will be required to submit appropriate documentation to substantiate the eligibility of those members entered.

### COMPETITOR PRE-REQUISITES

It is an expressed condition of entering the SHARKSKIN Australian & Interstate IRB Championships 2024 that a currently licensed accredited Surf Coach indicates that all members listed on the entries comply with the competitor pre-requisites as set out below.

Competitors entering the SHARKSKIN Australian & Interstate IRB Championships 2024 must comply with the competitor pre-requisites for drivers, crew and patients as outlined in the current edition of the SLSA Surf Sports Manual and any other subsequent circulars bulletins except where amended by this



Circular.

#### 3.3.2.4 Competitor Pre-Requisites

At the date of entry closure for the competition to be contested:

(a) Drivers are required to:

- (i) Be a minimum of seventeen years of age as at the date of competition.
- (ii) Hold their relevant state/territory maritime licence required to operate an IRB.
- (iii) Hold their IRB drivers award and be currently proficient as required by SLSA and have logged twenty (20) hours specific in-water IRB competition driving training under the supervision of a currently accredited SLSA Coach – IRB Events Elective.

**Note:** Once the initial 20 hours has been signed off there is no minimum hour requirement required for future years provided that the driver holds the IRB driver's award and is currently proficient as required by SLSA.

- (iv) Be endorsed by a currently accredited SLSA Coach – IRB Events Elective as being competent for IRB competition.

**Note 1:** Once the initial 20 hours has been signed off, an annual competition competency endorsement is required by a currently accredited SLSA Coach – IRB Events Elective.

**Note 2:** In all training and competition it is compulsory for drivers to wear high visibility (conspicuous colour) SLSA approved level 50 Australian Standard (AS4758) lifejackets or Type 2 (AS1499-1996) lifejackets. (Level 50S lifejackets unless listed on the SLSA Approved Gear and Equipment List are not approved.) It is not required for high visibility safety vests to be worn over the top of lifejackets. See also Section 2 of the Surf Sports Manual.

**Note 3:** The wearing of approved helmets is optional for drivers in both training and in competition. See also Section 2 of the Surf Sports Manual.

(b) Crewpersons are required to:

- (i) Be a minimum of sixteen years of age as at the date of competition.
- (ii) Hold their IRB crewpersons award and be currently proficient as required by SLSA and have logged twenty (20) hours specific in-water IRB competition driving or crewing training under the supervision of a currently accredited SLSA Coach – IRB Events Elective.

**Note:** Once the initial 20 hours has been signed off there is no minimum hour requirement required for future years provided that the crewperson holds the IRB crewperson's award and is currently proficient as required by SLSA.

- (iii) Be endorsed by a currently accredited SLSA Coach – IRB Events Elective as being competent for IRB competition.

**Note 1:** Once the initial 20 hours has been signed off, an annual competition competency endorsement is required by a currently accredited SLSA Coach – IRB Events Elective.

**Note 2:** In all training and competition it is compulsory for crewpersons to wear high visibility (conspicuous colour) SLSA approved level 50 Australian Standard (AS4758) lifejackets or Type 2 (AS1499-1996) lifejackets. (Level 50S lifejackets unless listed on the SLSA Approved Gear and Equipment List are not approved.) It is not required for high visibility safety vests to be worn over the top of lifejackets. See also Section 2 of the Surf Sports Manual.

**Note 3:** The wearing of approved helmets is optional for crewpersons in both training and in competition. See also Section 2 of the Surf Sports Manual.

(c) Patients are required to:

- (i) Be a minimum of fifteen years of age as at the date of competition and be a current proficient Bronze Medallion holder.



- (ii) Hold their IRB crewpersons award and be currently proficient as required by SLSA and have logged twenty (20) hours specific in-water IRB competition driving or crewing training under the supervision of a currently accredited SLSA Coach – IRB Events Elective.

**Note:** Once the initial 20 hours has been signed off there is no minimum hour requirement required for future years provided that the crewperson holds the IRB crewperson's award and is currently proficient as required by SLSA.

- (iii) Be endorsed by a currently accredited SLSA Coach – IRB Events Elective as being competent for IRB competition.

**Note 1:** Once the initial 20 hours has been signed off, an annual competition competency endorsement is required by a currently accredited SLSA Coach – IRB Events Elective.

**Note 2:** In all training and competition it is compulsory for participants to wear high visibility (conspicuous colour) SLSA approved level 50 Australian Standard (AS4758) lifejackets or Type 2 (AS1499-1996) lifejackets. (Level 50S lifejackets unless listed on the SLSA Approved Gear and Equipment List are not approved.) It is not required for high visibility safety vests to be worn over the top of lifejackets. See also Section 2 of the Surf Sports Manual.

**Note 3:** The wearing of approved helmets is compulsory for participants both training and in competition (except the Rescue Tube Race where it is optional). See also Section 2 of the Surf Sports Manual.

- (d) Handlers, at the date of competition, are required to:

- (i) Be a minimum of fifteen years of age as at the date of competition and be a current Bronze Medallion holder.
- (ii) Hold the IRB crewpersons certificate and be currently proficient as required by SLSA.
- (iii) Be a member of the same club or team as the crews and be entered at the competition (exemption may be given by the Championship Referee for a member of another club or team to be a Handler provided that the handler is entered at the competition).
- (iv) Wear a competition cap and shall be required to wear a distinctive high visibility pink, orange, yellow, green or red coloured vest as determined by SLSA (or relevant SLS Event Organiser) if entering the water beyond knee depth.

Alternatively, handlers may wear a high visibility (conspicuous colour) SLSA approved level 50 Australian Standard (AS4758) lifejacket or Type 2 (AS1499-1996) lifejackets. (Level 50S lifejackets unless listed on the SLSA Approved Gear and Equipment List are not approved.) It is not required for high visibility safety vests to be worn over the top of lifejackets.

- (v) Comply with all instructions of the officials.
- (vi) Make every effort to ensure that they, or the equipment that they are handling, does not impede another crew, otherwise both their competitor and the handler may be subject to disqualification.

- (e) Competitors should be conversant with all current specifications, competition rules and event conditions etc. pertaining to IRB competition and comply accordingly. Attention is also drawn to other relevant sections of the Surf Sports Manual including *Section 2 – General Competitive Conditions* and any other relevant circulars or bulletins that must also be complied with.

## TRAINING LOGS

The IRB Training Hour requirements for competition, from April 2024, will now become a Member award, "IRB Training – Competition Eligibility". This is required to be updated yearly and is a prerequisite for entry into IRB competition. The pre-requisite for this award will be a proficient Silver Medallion IRB Driver OR Proficient IRB Crew. Clubs will be required to ensure competitors are proficient in this award (including completion & proof of the required 20hrs training) on SurfGuard before entering competitors into SEMS as this will be an award requirement for entry.





The award “IRB Training – Competition Eligibility” has a fixed 12 month expiry and will need to be renewed each year for the annual competition competency endorsement.

Per the current edition of the Surf Sports Manual (SSM 3.3.2.4) the following competition roles are required to now possess the “IRB Training – Competition Eligibility” award on SurfGuard prior to being entered into IRB Competition via SEMS:

- IRB Drivers
- IRB Crewpersons
- Patients

Drivers must have logged their initial 20 hours and once the award is attained, there is no further training requirement required provided the competitor is currently proficient as required by SLSA. However, once the award ‘IRB Training – Competition Eligibility’ is attained, an annual competition competency is still required by currently accredited SLSA Coach – IRB Events Elective.

Crewpersons must have logged their initial 20 hours and once the award is attained, there is no further training required for future years provided that the crewperson holds the relevant award and is currently proficient as required by SLSA. As per IRB Drivers, an annual competition competency is still required prior to competing.

Patients must have their logged their initial 20 hours and once the award is attained, there is no further training required for future years provided that the crewperson holds the relevant award and is currently proficient as required by SLSA. Once Patients have completed the award ‘IRB Training – Competition Eligibility’ an annual competency is still required per conditions noted above for Drivers & Crewpersons.

**Copies of Members’ IRB Training Logs must be uploaded by their competing Club to the Member’s SurfGuard account the ‘documents’ functionality.**

### **ENTRY LIMITATIONS**

All Interstate IRB Championships events shall be contested by teams representing their State. States shall enter only two teams in each event.

All Australian IRB Championships events shall be contested by teams representing Clubs. Clubs can enter as many eligible crews as they wish into the Open IRB Championships, Masters IRB Championships and U23 IRB Championships for 2024 providing each competitor complies with the entry limitations as detailed in the current edition of SLSA Surf Sports Manual (detailed under) and any other subsequent circulars or bulletins.

#### **3.3.2.5 Entry Limitations**

- (a) IRB competition may be conducted in different categories of age, grade and gender.

**Note:** The age divisions conducted at the SHARKSKIN Australian IRB Championships are Open, U23 and Masters. The Interstate Championships are conducted in the Open Division only.

- (b) A competitor may compete or nominate to compete in a maximum of twelve events plus the IRB Relay(s) at any one competition. However, in the event of adverse weather, surf conditions, water temperature, wind chill, and/or hyperthermia risk etc, the Competition Committee, at its absolute discretion, may reduce the maximum number of events in which each competitor may participate at the competition.

**Note:** Competitors are only allowed to compete across twelve events plus IRB Relay(s) across three Championships being U23’s, Masters & Opens contested at the Australian IRB Championships. It is clarified that the Australian IRB Championships is one competition with events currently conducted



in Open, U23 and O35 age divisions. This means that a competitor may compete or nominate to compete in a maximum of twelve events plus the IRB Relay(s) at Australian IRB Championships.

- (c) A driver and/or crew may compete in a particular event once e.g., a driver cannot compete in an event in one team as a driver and compete again in the same event as a driver or crewperson in a separate team.

**Note:** This does not preclude an eligible driver, crew or patient from the same team swapping roles in different rounds of the same event.

- (d) If eligible to compete in multiple grades or age categories, drivers and crewpersons may do so, but may only compete in a particular event once e.g., Open Male Rescue is a different event to the Under 23 Male Rescue (refer to Competition Definitions in Section 2 for further detail).
- (e) IRB patients are to be considered as gender neutral with respect to their participation in male and female IRB events.
- (f) Patients may compete in any grade, age or gender category events but may only compete in a particular event once.
- (g) Attention is also drawn to other relevant sections of the Surf Sports Manual including *Section 2 – General Competitive Conditions* and any other relevant circulars or bulletins which must also be complied with.

## COMPETITION PRIORITIES AND TIERING OF EVENTS

Competition will commence on Thursday July 18, 2024. The SHARKSKIN Australian & Interstate IRB Championships 2024 will be conducted within strict and challenging timeframes.

In order to meet these timeframes, in their sole discretion, the IRBCCC and the Championships Referees may need to adjust the order, draws and priority of events and priority of the Championships completion. The competition time schedule is any time (in required daylight) from 7:30am on Thursday 18 July – 4:30pm on Sunday 21 July. All teams need to be available to compete at these times. This also includes;

- Cuts in rounds in excess of the numbers as outlined in the Surf Sports Manual for either or both Masters and U23 Championship events.
- Cuts in rounds in excess of the numbers as outlined in the Surf Sports Manual for the Open Championships.
- The priority/tiering of Championships (from highest to least) is seen as:
  - Opens
  - Interstate
  - U23
  - Masters
- The priority/tiering of events (from highest to least) is seen as:
  - Surf Rescue
  - Mass Rescue
  - Teams Rescue
  - Tube Rescue
  - IRB Relay
- The priority for completion remains for the Australian Open IRB Championships and schedule and conduct of events may change and commence any time from 7:30am Thursday 18 July, i.e., Opens may commence on Thursday 18 July.
- In the event of adverse weather and/or other conditions or event time constraints impacting on the timely completion of the Championships, preference will be given to the Australian Open IRB Championships.



## **INTERNATIONAL COMPETITORS/TEAMS**

Conditions of entry for international competitors:

1. SLSA reserves the right to invite and/or accept entries from international competitors and club teams to compete in any event at the SHARKSKIN Australian IRB Championships.
2. International club teams must be a genuine club team (not composite) and must compete in club colours to be eligible to compete.
3. All international competitors and club teams must gain international clearance from their governing body and must be submitted to SLSA prior to competition to compete at the SHARKSKIN Australian IRB Championships 2024.

## **RESERVES**

Reserve competitors may be entered into the carnival to avoid late entry fees when making substitutions at the event. All reserve competitors must meet the respective requirements for the position in which they have been nominated as a reserve.

## **SUBSTITUTIONS**

Substitutions will be allowed as per the current edition of the Surf Sports Manual (if the competitor is entered into the Championships) and no charge will be taken to make these changes.

If a substitution occurs with a new competitor who is not entered into the competition - this will be considered a late entry, and they will be charged accordingly (see Late Entry section in this circular). In this situation advice and competitor's details must be provided to the event administration by 4pm Wednesday 17 July 2024.

Any competitor substituted into an event must meet the correct requirements as set out by SLSA for the position for which they are substituted into.

In the case of a genuine injury the IRBCCC may consider an application for a substitution of an eligible driver or crew (but not both) who has already competed in a different age category of the same event into an older or younger age category of the event.

## **PENALTIES: BREACH OF ENTRY REGULATIONS**

It is mandatory that all competitors be listed in SEMS for each Club. Entry of competitors who are ineligible due to non-qualification or proficiency, default of personal patrol hour obligations, or other breach of association or club entry regulations will be referred to SLSA for action.

## **EQUIPMENT**

### **COMPETITION EQUIPMENT**

Each Club/State shall be responsible for provision of their team's equipment.

Insurance generally shall be the responsibility of the individual competitors, their Clubs or State/Territory. Surf Life Saving Australia will not accept responsibility for loss, damage, or theft of equipment.



## EQUIPMENT CONTAINERS - MIAMI

States and Clubs transporting containers to Miami must contact the SLSA events team ([events@slsa.asn.au](mailto:events@slsa.asn.au)) by no later than Wednesday 10 July 2024 and provide the following information:

- Container Size (max. 20ft)
- Container Arrival Date
- Container Pick Up Date
- Club Organiser's Name
- Club Organiser's Phone No
- Club Organisers Email
- Transporting company (e.g. Toll)
- Container ID #

If your Club or State is shipping a container to Miami Beach, please ensure it is a maximum of a 20ft container. If containers are greater than 20ft, they will be parked offsite. There will not be a telehandler forklift on site so please ensure the trucks delivering the containers can offload them.

Deliveries to site can be received from 9:00am Tuesday 16 July 2024. Exact location for deliveries will be confirmed upon receipt of your container information details.

## SCRUTINEERING

All IRBs, motors, and accessories (including fuel) must be scrutineered prior to competition and must have passed the safety and compliance checks conducted by the Scrutineers or as determined by Surf Life Saving Australia.

Scrutineering will be conducted in accordance with IRB Equipment Requirements, Scrutineering and Compliance. Technical scrutineering (including fuel) may also take place randomly before competition, during competition or at the conclusion of the championships.

Any equipment (including fuel) that has not passed the scrutineering requirements shall be referred to the Championship Referee for adjudication.

Scrutineering for all clubs occur on Wednesday 17 July from 9:00am - 4:00pm. **All** IRBs, motors and accessories must be scrutineered within these times and prior to competing. Scrutineering will occur in the Scrutineering area of the gear & equipment compound at Miami Beach SLSC.

Clubs are asked to email [events@slsa.asn.au](mailto:events@slsa.asn.au) with their preferred 30 minute time slot for scrutineering once club entries have been completed.

**Please Note:** any club wanting a scrutineering time post 2pm, **MUST** be registered and ready to present all gear at 2pm. Any club not registered and ready to present will not be scrutineered.

The final scrutineering timetable will be released in the final carnival circular.

## PERSONAL PROTECTIVE EQUIPMENT

**Competing clubs and competitors are reminded that:**

- The list of SLSA lifejackets approved **for both** lifesaving operations and IRB competition is detailed in the SLSA IRB Gear and Equipment Regulations.



- All certified level 50 Australian Standard (AS4758) and Type 2 (AS1499-1996) life jackets are approved for IRB competitions provided that they are in high visibility (conspicuous) colour.
- SLSA does not permit the use of lifejackets or PFDs designed for use in surf skis, ocean kayaking, or other paddle sports, i.e., the design must be consistent with the lifejackets approved for SLSA lifesaving operations as detailed below.
- Other than the SLSA branded Rip Curl lifejackets approved for Victorian Competitors (refer to SLSA IRB Gear and Equipment Regulations), **Level 50S lifejackets are not approved for SLSA lifesaving operations or for IRB competition.**
- All Lifejackets are to be presented for scrutineering prior to use in competition.

## COMPETITION BRIEFINGS

### Team Manager Briefing

A mandatory briefing for State and Club Team Managers will be conducted on Wednesday 17 July 2024 at 5:00pm for **ALL** Championships. Clubs should have a maximum of two (2) personnel to attend the Team Managers Briefing. This briefing will be held in the Miami clubhouse and will also be online on Microsoft Teams with a link being sent out via TeamApp prior.

### Officials Briefing

The mandatory Officials Briefing will be held at the beginning of each competition day in the officials area.

## COMPETITION RULES

The general competitive conditions as detailed in the current edition of SLSA Surf Sports Manual, and in particular, Section 3.3 Inflatable Rescue Boat (IRB) Competition and any other subsequent circulars bulletins shall apply to the conduct of these events except where amended by this circular.

Attention will be paid to competitor's compliance to eligibility and pre-requisites for IRB competition, coaching history and patrol obligations as described in the above manuals, rules, and documents.

## MIXED IRB RELAY RACE

The Mixed IRB Relay Race shall be conducted as per SSM Section 3.3.4.5 except that two legs of the race must be completed by a male crew and two must be completed by a female crew (driver + crew person). It is up to each team to decide which leg is completed by what crew.

**No one driver, crew or patient is permitted to complete more than one leg of the event.**

## OPENING CEREMONY

On Thursday, 18 July 2023 at 1.45pm an Opening Ceremony will be conducted. Flag bearers from each State and Club teams are required to march into the arena as directed and assemble for the Opening Ceremony. Consideration will be given to allow competitors in the first events adequate time to change into their competition apparel.

## PROTESTS & APPEALS

A protest against a competitor or a team or against a decision of an Official must be lodged verbally with the Competition Liaison Officer within **5 minutes** of the completion of the event or the announcement of the result of an event.

A written protest must then be lodged with the Competition Liaison Officer within 15 minutes of the verbal protest being lodged. Protest forms can be obtained from the Competition Liaison Officer. The result of an event, if not already announced, will be withheld until the protest and any subsequent appeal is decided. The Competition Appeals Committee will deal with all protests referred to it by the Referee in terms of Section 14 of the current edition of the Surf Sports Manual.

Team Managers are reminded that both the Championship Referee and the Appeals Committee will not



entertain frivolous appeals, the decision for a disqualification will go through the Officials, Judge in boat and the Chief Judges before being posted so unless explicit evidence to that contrary will be classed as frivolous and dismissed by the Championship Referee. In this regard, please note that SSM (Clause 14.3.3b) states:

*“Where the Referee or the Area Referee or the Sectional Referee considers (in their absolute discretion) that a **protest is frivolous**, or not of a serious nature, they may choose not to accept the protest.”*

Please also note that the Team Manager retains the right (under SSM Clause 14.3.3b) to appeal the matter but the Appeals Committee will also consider whether the matter is frivolous in assessing the grounds for appeal.

An appeals fee of \$150.00 (incl. GST) must accompany all protest appeals when submitted to the Appeals Committee for adjudication. If an appeal is upheld the fee shall be returned forthwith. The decision of the Competition Appeals Committee is final and there is no right of appeal against that decision.

### INTERSTATE TEAM COMPOSITION

Due to the Interstate competition forming part of the National IRB Team selection, all Interstate teams will be single gender only.

Each State shall enter two Female and two Male teams of four persons that will be gender specific.

Both Female teams will compete in the Female Rescue Tube, Female Mass Rescue, Female Teams Rescue (One team) and Female Rescue events.

Both Male teams will compete in the Male Rescue Tube, Male Mass Rescue, Male Teams Rescue (One team) and Male Rescue events.

The IRB Relay will consist of two Gender specific Female crews and two gender specific Male crews. The Gender that does the Teams leg of the relay will be able to use non-gender specific patients.

States may also enter Development teams which will fall under the same selection requirements as the Interstate Teams



Further information around the Australian IRB Team Selection can be found in **Circular 61/23-24 Lifesaving World Championship IRB Selection Information & Team EOI**.

### **INTERSTATE DRAWS AND BALLOTS**

Tube, Rescue and Mass Interstate events will be conducted as semi-finals. Teams and Relay events shall be conducted as finals unless otherwise advised by the Championship Referee.

The Championship Referee or their delegate will undertake any other ballots required on the beach on the day of the competition.

### **INTERSTATE POINTSCORE**

The highest placed finisher from each Interstate team only, will accrue points towards the Interstate point score. The Second-place finisher from each Interstate team will not accrue any points towards the overall standings. State Development teams will not accrue any points regardless of finishing positions. All events conducted shall be of equal points and the State/Territory with the highest aggregate of points at the conclusion of the competition shall be declared the winner in each of the point score categories. The State/Territory with the highest aggregate of points at the conclusion of the Championships shall be declared the winner.

Point score points shall be allocated on a 7, 6, 5, 4, 3, 2, 1, basis for the positions 1<sup>st</sup> – 7<sup>th</sup> for each event contested. Nil points will be earned in the case of disqualification.

Where a dead heat occurs in the final of an event the States/Territories involved will share the placing and placing points relative to the finish placing. The next State/Territory to finish will receive the relative placing and placing points based on the number of individuals/teams finishing ahead of them. For example: if two individuals/teams finish equal 1<sup>st</sup> both individuals/teams shall receive 7 points each. The next placing individual/team shall be awarded 3<sup>rd</sup> place and 5 points.

If, when the Championships have concluded there is a tied point score, the State/Territory with the most 1<sup>st</sup> placings will be declared the winner. Failing this, the State/Territory with the most 2<sup>nd</sup> places to 6<sup>th</sup> places respectively will be considered to determine a winner. If, after this procedure there is no single winner, then the point score will be declared a tie and dual trophies will be presented.

States may be offered the opportunity for development teams to participate in the Interstate Competition. Any development teams are not eligible for placings, points, or medals.

### **SLSA CODE OF BEHAVIOUR/MISCONDUCT**

Misconduct before, during and after the Championships will not be tolerated. Offending members risk disciplinary action against themselves and their Clubs. Please refer to the current Edition [Surf Sports Manual](#) and, in particular but not limited to, section 2.27 SLSA Code of Behaviour, section 2.28 Abuse/Inappropriate Behaviour and section 2.29 Competing Unfairly and also to SLSA Policy 6.05 – Member Protection Policy (available online at [Member's Area](#) > Document Library > Governance/Policies > Policy 6.05).

### **COMPETITION MANIPULATION AND ANTI-DOPING**

#### **Competition Manipulation**

The SLSA National Policy on Competition Manipulation and framework covers all SLS Events that are conducted by SLSA, State Centres, Branches and Clubs includes special events, conducted by third parties sanctioned by an SLS entity and any event, competition or series connected with Surf Lifesaving. Please refer to Policy Document 5.11 for further details.

#### **Anti-Doping**



Members have responsibilities under Policy 5.02 Anti-Doping Policy and Policy 6.23 Illicit Drugs in Sport (both available in the SLSA Members Portal).

It is strongly recommended that all Athletes, Coaches, Team Managers and Support Personnel complete the online Sports Integrity Australia “Clean Sports 101” module and conduct at least one (1) anti-doping education activity with all competitors from the Club prior to competition. ## **MISCONDUCT & REPORTING**

Misconduct before during and after the Championships will not be tolerated. Offending members risk disciplinary action against themselves and their club and may be pulled from competition instantly.

## **MEDIA STATEMENTS**

States/Territories & Clubs shall be permitted to promote the event and or their Club team within their own State (subject to SLSA approval). However, no Competitor, Team Manager, Official or spokesperson for a State shall make media statements that could bring the Australian & Interstate IRB Championships 2024, its sponsor, or Officials into controversy. Such statements shall be deemed to be a breach of SLSA discipline and may be dealt with accordingly.

Complaints regarding the organisation of the Championship, or any other matters, should be directed through the appropriate SLSA channels, and will be dealt with by the responsible section, or officers. Such official complaints will be acknowledged.

## **SPONSORSHIP**

As detailed in the SLSA Sponsorship Policy teams may be asked to wear sponsors apparel during the presentation of medals and trophies. Apart from any SLSA sponsorship no items giving commercial identification may be worn during the official Presentation Ceremony.

In the event of clubs/individuals having conflicting sponsorship with an event sponsor, the association sponsorship policy must be adhered to.

Teams when entering the marshalling arena and competing must be ‘clean’ in competition gear with no sponsor’s identification unless the Club also has the event naming rights sponsor as its sponsor. Should the event naming rights sponsor competition apparel for the event teams will be required to wear the event naming rights sponsor’s competition apparel or in the event of conflict with a Club team sponsor, compete in SLSA branded apparel. If no such apparel is provided teams are to compete in SLSA branded apparel.

At the conclusion of events, place getters may be offered items of apparel identified with the event sponsor. It may be possible that TV interviews will be undertaken with prominent competitors, and in such cases, they may be asked to wear one of the official sponsor T-shirts and/or caps. Further, competitors may be required to carry the event sponsor’s logos on craft, boats and equipment.

Where physically possible, no existing signage will be covered. Those craft with rival sponsors to the event sponsor will not be required to display the event sponsors signage and/or to cover the rival sponsor’s signage.
