Appointment of SEMC's will be made by the SLSNSW Director of Lifesaving in consultation with the SLSNSW Board. The appointment of SEMC's will be made after the close of nominations and an appointment letter will be sent to successful applicants via email.

ROLE PURPOSE

The Safety and Emergency Management Coordinator (SEMC) is responsible for always ensuring a safe competitive environment for surf sports participants and mitigating any foreseeable participant risk as it might arise. The SEMC is responsible for coordinating the response to any emergency during competition, per the SLSNSW SOP's and the event specific Safety Operations Manual (SOM). The SEMC will also be responsible for all 'back of beach' areas with respect to safety and WHS with respect to structures and activities associated with the event.

The SEMC works collaboratively with carnival referee(s) and the Carnival Committee to ensure the provision of a safe competitive environment, ensure risk mitigating practices are in place and advise of potential risk factors which may impede the continuation of safe competition which require the adjustment of the competitive environment to allow competition to continue or the suspension of the event. The SEMC leads and chairs the Safety and Emergency Committee (SEC).

MINIMUM QUALIFICATIONS / REQUIREMENTS

Surf Life Saving NSW is looking for nominations which meet the following requirements:

- o Silver Medallion Patrol Captain (SMPC) or Beach Management (SMBM)
- Current First Aid Qualification
- Silver Medallion Aquatic Rescue (desirable)
- Surf Sports Official's Accreditation (desirable)
- PUAOPE012 Control a Level 1 Incident (desirable)
- Current and financial member of SLSNSW club
- Class C Drivers licence
- Branch Endorsement

When SEMC appointments have been finalised, all members who nominated will be notified by an Official Appointment Memo. Appointments will also be shared on the event page.
