Summary:	This Circular contains the relevant details for entering Super Surf Teams League

This event circular contains information in reference to the conduct of the 2024/25 Super Surf Teams League (SSTL) to be over two rounds:

Round	Location	Date
Round 1	Wanda, NSW	8.00am Saturday 14 December 2024
Round 2	Wanda, NSW	8:00am Sunday 15 December 2024

EVENT INFORMATION

States will be responsible for the selection of their representative teams and make their own arrangements regarding equipment, transportation of teams and outfitting. SLSA will supply the competition lycras.

Insurance for all competition equipment including tents, trailers and surf craft is the responsibility of the States. SLSA will not accept the responsibility for loss, damage, or theft of equipment.

For event management purposes, SLSA will recognise a maximum of two (2) team management officials for each team.

The 2024/25 SSTL will be divided into 2 categories:

- 1. Open SSTL open to all proficient competitors from the U17, U19 and Open age groups.
- **2. U17 SSTL** open only to competitors from the U17 age group. Each State will be permitted to enter 1 x U17 team only.

Separate point scores will be conducted over both categories.

Note: Each team must include 4 males and 4 females. Once a competitor represents one team, they are not able to transfer to another for the remainder of the series.

TEAM COMPOSITION

SSTL U17 TEAM COMPOSITION

A U17 SSTL Team (8) will consist of the following:

- Each State is permitted to enter 1 x U17 SSTL Team only
- 4 x male competitors
- 4 x female competitors
- All competitors must be proficient and eligible to compete in the U17 age category for the 2024/25 season.
- Competitors competing in the U15 age group for the 2024/25 Season are not permitted to compete.
- A team's composition may vary from round to round however the team can nominate no more than 10 athletes as part of their squad. These 10 athletes must be included in the team configurations provided to SLSA.





SSTL OPEN TEAM COMPOSITION

A SSTL Team (8) will consist of the following:

- 4 x male competitors
- 4 x female competitors
- All competitors must be proficient and eligible to compete in the Open category for the 2024/25 season (i.e., U17, U19 or Open).
- Competitors competing in the U15 age group for the 2024/25 Season are not permitted to compete.
- A team's composition may vary from round to round however the team can nominate no more than 10 athletes as part of their squad. These 10 athletes must be included in the team configurations provided to SLSA.

HANDLERS

Each Team is permitted one Handler to assist with craft. Handlers must wear a Team Competition cap and a high visibility vest (States to provide).

TEAM SHEETS

States are required to complete the team entries via the Sports Event Management System (SEMS) as well as complete the team management and event configuration in the attached electronic template (excel spreadsheet) and send to SLSA (events@slsa.asn.au) no later than close of business, Monday, 2 December 2024.

<u>Note 1:</u> Changes after this date will only be permitted subject to injury or other unforeseen circumstances. No changes to any team entries shall be permitted once the first event has commenced although teams may substitute within the team as required. Evidence **MUST** be provided in the form of a medical certificate or relevant documentation.

Note 2: In the event of an athlete withdrawing from a team. Team Management must

- a) Gain approval from the Competition Committee to replace the withdrawn team member (contact SLSA who will send to Competition Committee Chair)
- b) Ensure the new team member complies with the rules set out above under Team Selection

COMPETITION BRIEFINGS

A briefing for Team Managers and key Officials will be conducted by the Event Referee prior to the commencement of each round. Teams should have a minimum of one and maximum of two personnel attend the briefing. The Officials to be in attendance include the Event Referee, Safety and Emergency Management Coordinator, and key Officials/SLSA personnel.

EVENT COMMUNICATION

The SSTL will be using the 'Team App' smartphone application to send out updates and notifications to Team Managers and competitors. Please see the instructions below to understand what 'Team App' is and how to use it. It may also be helpful to visit the website for further clarification at https://www.teamapp.com/fags.

HOW DO I USE TEAM APP?

Download 'Team App' from the App Store or Google Play. Once you have downloaded the app and created your user login, search for 'Super Surf Teams League' in the search bar at the top of the screen and click on the event to join. From here you will be able to access news feeds, event timings and where to find all the latest and up to date information on the event. By joining the event and turning on your mobile app notifications, you will receive an immediate text and email update as they are posted, ensuring you never miss any important information!

'Team App' is applicable for all Apple iPhones, iPads, and iPods, plus most Android mobile devices.





COMPETITION EQUIPMENT AND SPECIFICATIONS

Each team shall be responsible for the provision of their own surf craft. All equipment used in competition is to comply with SLSA specifications. Random scrutineering of equipment may occur during the 3 Rounds of the SSTL.

EVENT CONDITIONS

The general competitive conditions as detailed in the current edition of the Surf Sports Manual and any subsequent bulletins shall apply to the conduct of these events except where amended by these rules.

All events where possible and, conditions permitting, shall be conducted as finals – except Beach Sprint and Flags which will be conducted with heats and finals.

Each team will field only one (1) competitor or team per event.

The primary amendments are:

a) Water Courses:

Water events will be conducted as traditional course around the buoy courses set for the Nutri Grain Ironman and Ironwoman Series as follows

b) Water Event Starts:

Unless otherwise advised, all water events shall be started on the beach approximately 15 metres from the water's edge (run start). Craft will be placed in front of the start line and as close as practicable to the water's edge. Handlers are not required for the start of events except for the Ski events where at the Competition Committee's discretion, Handlers may be utilised to hold the craft in the water to avoid the dragging/carrying of skis into the water.

c) Water Event Finishes:

Unless otherwise advised, all water events shall finish as per the Ironperson races (run finish). Craft and paddles may be abandoned after rounding the last turning buoy of the swim course. Handlers are to be used to remove craft and paddles from the course.

d) Change Over Area and Tagging for Relay Style Events:

In all relay style events the Referee will designate a Changeover Area that will commence 5 metres before the finish arch (southern side) and finish at the arch. The incoming athlete will run from the water's edge around the southern turning flag towards the finish arch. In the Changeover Area a tag must take place between the incoming competitor and the outgoing competitor. The tag can take place on any part of the body. Any breach of the Changeover Rule may result in disqualification.

e) Mixed Ocean M 8 person Team Relay:

Fixed order of run, swim, board ski. To be run as per the rules outlined in the current edition of the Surf Sports Manual. The event will be conducted over an M Shape Course however if conditions dictate the event may revert to a traditional course. The Referee will confirm details at the Team Manager meeting.

f) Entry Condition:

If a Member has been injured & their claim processed through iCare (WorkCover Authority New South Wales) and wishes to compete in an SLSA competition or returning to SLSA Surf Patrol Duties, then they MUST complete & submit a Return to Surf Duties Form BEFORE returning to ensure full medical clearance.

Note 1: Refer to SLSA Policy 5.04 "Competition Eligibility". All selected competitors must be proficient to the relative SLSA Award for their age group and, as appropriate, have satisfied the patrol requirements as specified by their Clubs. Competitors and Team Management must also be current financial members of their respective surf club.

DRAWS

SLSA will be utilising Live Heats wristbands for the marshalling and recording process. All





competitors who have an existing Live Heats wristband are to bring these wristbands.

- All results and draws will be posted on <u>liveheats.com/slsa/</u>
- All draws will be random and drawn through Live Heats
- The referee will undertake any other ballots required on the beach on the day of the competition.

POINTSCORE

For the 24/25 SSTL two separate point scores will be conducted:

- Open SSTL point score and,
- U17 SSTL point score

Within each Round all races will be allocated maximum points with each subsequent place getter receiving 1 point less. A separate and cumulative point score will be kept for each Round.

The maximum number of points equates to the number of teams competiting in each division (i.e. if there are 12 teams competing in the open division, first place will receive 12 points).

If a competitor or a team fails to start, fails to finish, or is disqualified in a race – they will receive NIL points for that race.

At the conclusion of each Round all Teams will then be ranked from highest to lowest based on the aggregate point score for that Round. The Team with the highest ranking will then be awarded maximum





points with each subsequent Team being awarded 1 point less.

Overall Point Score

For both the Open SSTL and the U17 SSTL the Team with the highest point score at the conclusion of Round 2 shall be declared the winner. Further to this if there is a tied point score, the Team with the most 1st placings shall be declared the winner. Failing this, the Team with the most 2nd placings to the last placing points awarded respectively will be considered to determine a winner. If, after this procedure there is no single winner, then the point score will be declared a tie and dual trophies will be presented.

PRESENTATIONS

Teams will be competing for the Open Super Surf Teams League Trophy and the U17 Super Surf Teams Trophy. Medals will also be awarded to 1st, 2nd, and 3rd for both the Open point score and the U17 point score.

PROTESTS

In the event of a protest by a competitor or team there will be no right of appeal as the Referee's decision, in consultation with the Deputy Referee shall be final.

In dealing with the protest – the Referee has the discretion to (but not obligated to):

- Speak to any further person he/she believes is appropriate and /or
- View any video or broadcast footage that may assist in his/her decision

All Placings are deemed final upon the Referee declaring the results as confirmed. No protest can be lodged after the confirmation of the results.

INJURY/ILLNESS/ TEAM SUBSTITUTION

A Team may replace an athlete in their team up until the commencement of the first race of each Round. After competition commences in each Round a Team cannot make a replacement from outside of their Team. This includes States that have multiple Teams – substitutions cannot be made between Teams. Once a competitor represents a team, they are ineligible to represent another for the remainder of the series.

SLSA CODE OF BEHAVIOUR

SLSA expects that all members involved in SSTL will co-operate to ensure a positive public image and to participate in a spirit of goodwill and sportsmanship.

The SLSA Code of Conduct, Competing Unfairly and Abuse/Inappropriate clauses etc. are contained in the current edition of the Surf Sports Manual and any subsequent bulletins.

Any incidents or behaviour likely to cause embarrassment or damage to the reputation and/or image of lifesaving competition will be managed as prescribed in the current edition of SLSA's Rules, Surf Sports Manual, and any subsequent bulletins.

MEDIA STATEMENTS

Teams shall be permitted to promote the event and or their State/Territory Team within their own state. However, no competitor, Team Manager, Official or spokesperson for a Team, shall make media statements that could bring the SSTL, its sponsor, or Officials, into controversy. Such statements shall be deemed to be a breach of SLSA discipline and may be dealt with accordingly.

Complaints regarding the organisation of the SSTL, or any other matters, should be directed through the appropriate SLSA channels and will be dealt with by the responsible section, or officers. Such official complaints will be acknowledged.





THEFT

Any person/s found stealing signage or any equipment owned by Surf Life Saving Australia, the hosting authority, states, or another individual may be immediately reported to the police and that person/s be brought before a SLSA Disciplinary Committee.

Please note that automatic disqualification of the team from the SSTL may occur if any member is found guilty of theft.

MATCH FIXING

The SLSA National Policy on Match Fixing and framework covers all SLS Events that are conducted by SLSA, State Centres, Branches and Clubs including special events, conducted by third parties sanctioned by an SLS entity and any event, competition or series connected with Surf Lifesaving. Please refer to Policy Document 5.11 for further details.

SLSA ANTI-DOPING POLICY

Surf Life Saving Australia supports the Australian Government, the Australian Sports Commission, the Australian Olympic Committee, and Sports Integrity Australia (SIA) in their efforts to eradicate the use of drugs in sport. SLSA has published an anti-doping policy, which will be adhered to for this event.

It is highly recommended all competitors and club members (including coaches, handlers, and support personnel) complete the SIA online e-learning program (Level 1) to ensure all personnel are aware of contemporary issues pertaining to anti-doping. Further to this, it is highly recommended that each team, under the direction of the management, undergo at least one anti-doping education and awareness activity as a group.
